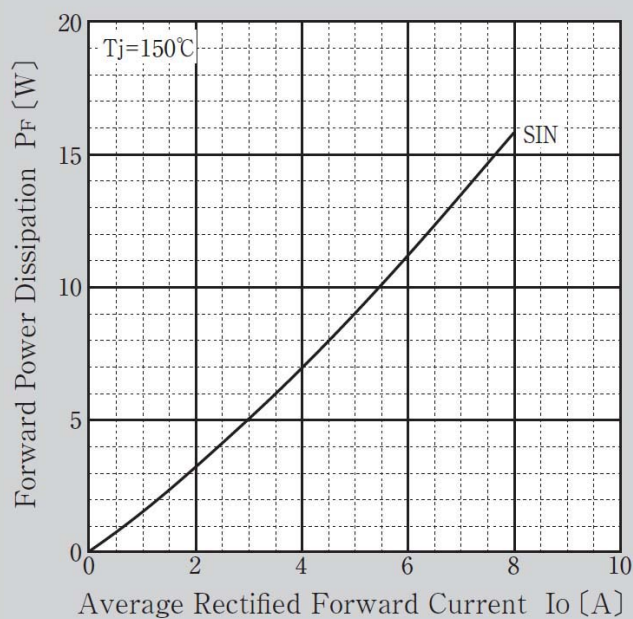

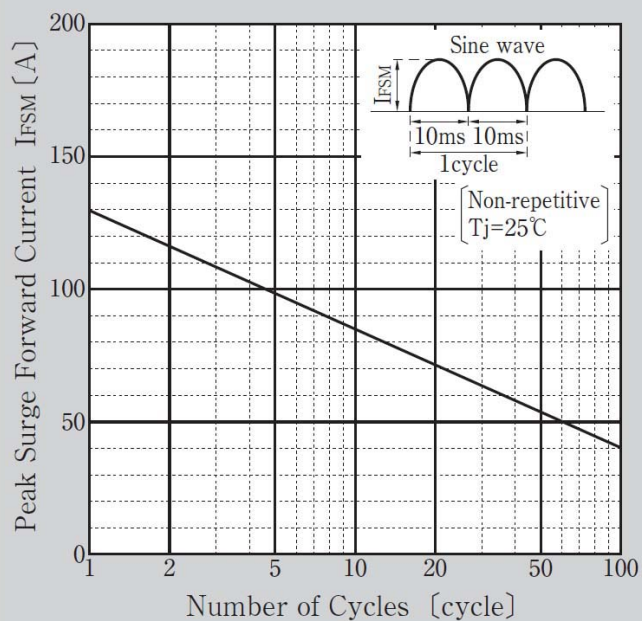
Forward Voltage



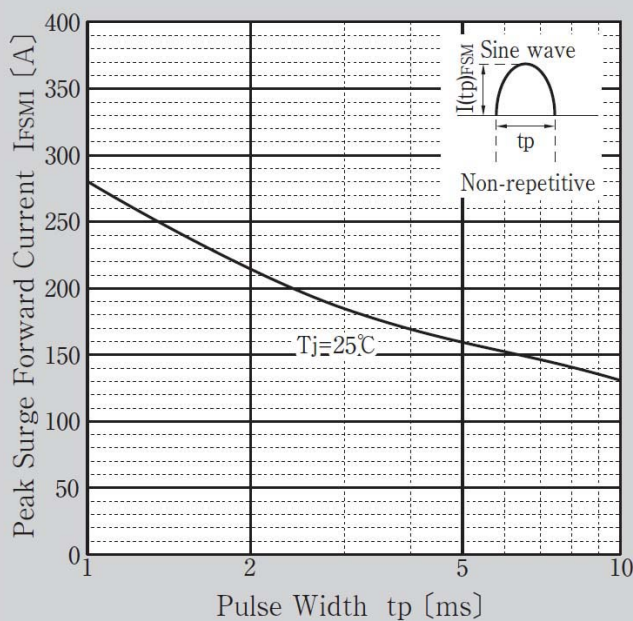
Forward Power Dissipation



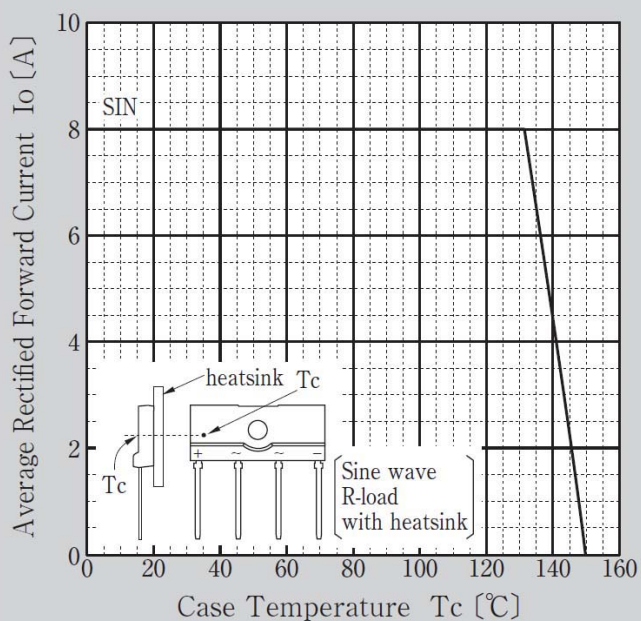
Peak Surge Forward Current Capability



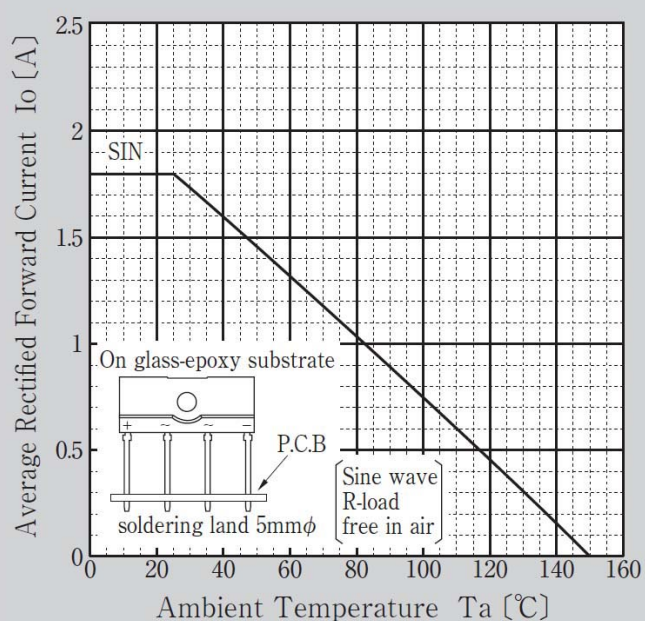
Peak Surge Forward Current Capability



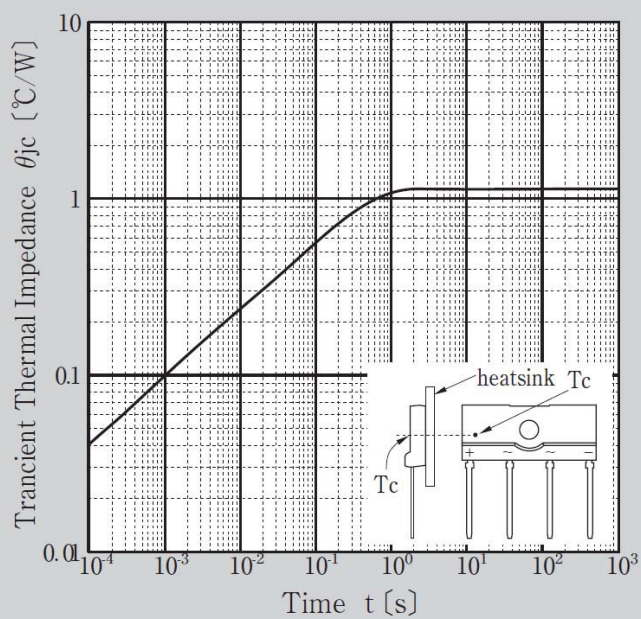
Derating Curve



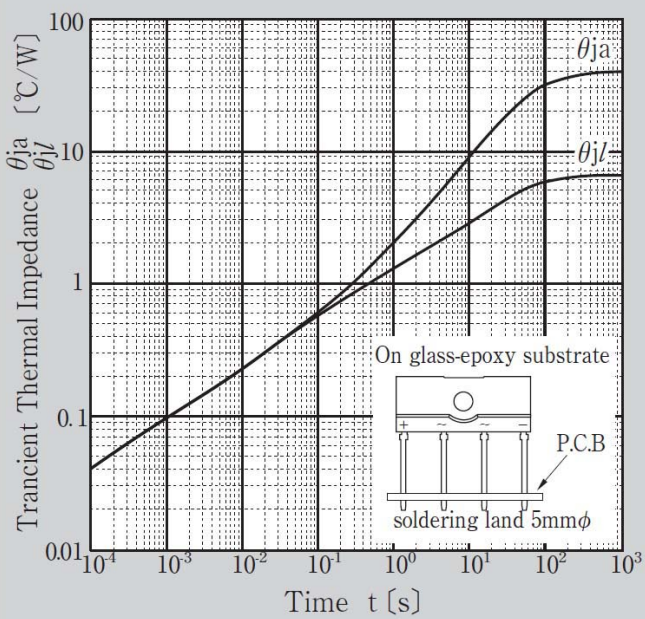
Derating Curve



Transient Thermal Impedance

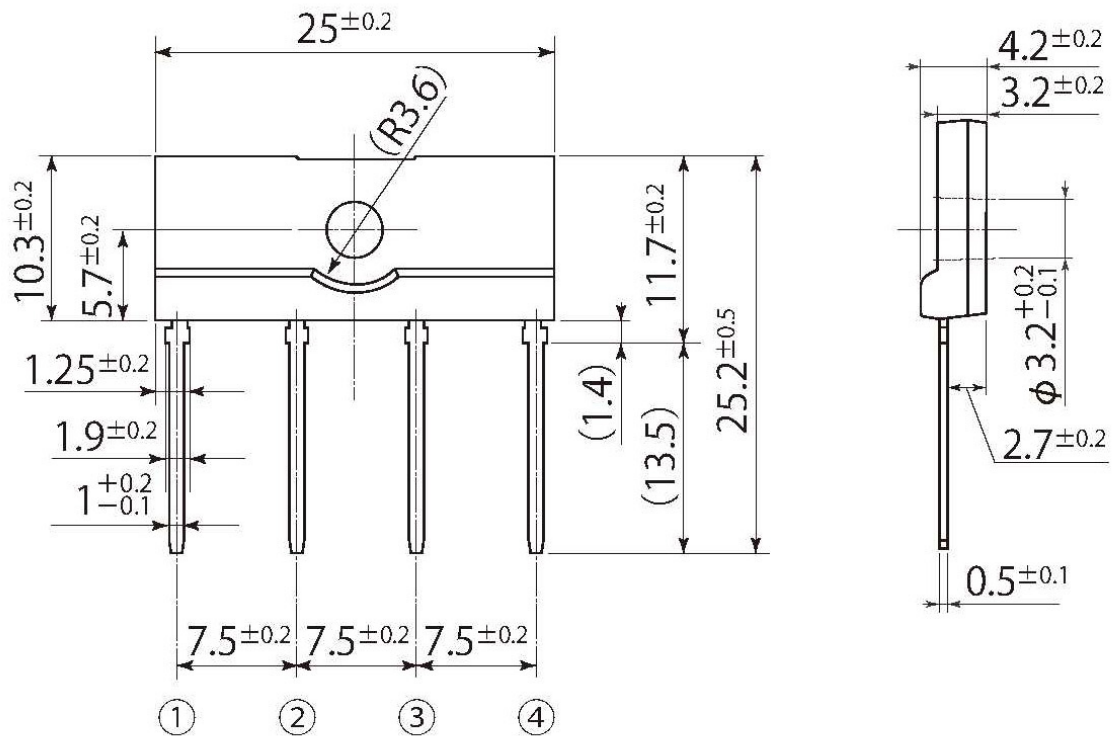


Transient Thermal Impedance
